## Pups in the Park Calendar Competition

## **Terms and Conditions of Entry**

- 1. This competition is open to both novice and professional photographers of all ages living in the UK. Entrants under the age of 16 must have a parent or guardian consent to enter.
- 2. By submitting an image in the Pups in the Park Calendar Competition, each entrant agrees and acknowledges that Scolton Manor Park/Pembrokeshire County Council is permitted to receive their contact information. The winning entrants agree to the use of their name, winning image and details about their pup being used in related promotional material and social media posts. All personal information will be used and held by Scolton Manor Park (SMP) in accordance with Pembrokeshire County Council's (PCC) Privacy Policy. A copy of the Privacy Notice and full UK GDPR statement is available on the PCC website.
- 3. The 12 winners of the competition will have their winning image printed in our 2023 calendar and will receive one complimentary copy of the calendar. There are no cash or prize alternatives.
- 4. Entries must include the entrant's name and contact number, the location where the photograph was taken and some information we can share about the pup(s) pictured in the photo.
- 5. Entries should be submitted by email attachment to <u>nikki.caldwell@pembrokeshire.gov.uk</u> no later than 23:59 on Friday 26<sup>th</sup> August 2022 and the subject must read '2023 Pups in the Park Calendar Competition'. Submissions received after this date and time will not be considered. Successful receipt of competition entries will not be acknowledged. We regret that we are not able to accept postal entries or entries sent via Facebook. SMP cannot accept any responsibility for any technical failures or reasons for not receiving an image before the closing date and time.
- 6. Submitted images must be in colour. An appropriate amount of manipulation / editing / correction is allowed. Panoramic photos may not be suitable for the intended print purposes of these images.
- 7. All images must be taken onsite at Scolton Manor Park.
- 8. There is no charge for entering the competition. However, entrants are only allowed to submit a maximum of five images for consideration.
- 9. Images need to be submitted in landscape orientation as JPEG files and of a high enough resolution for printing (300dpi). Some mobile phones may not be able to support these requirements. Emails or files larger than 10MB may be rejected by our email server.
- 10. The winning entries will be those that are judged by SMP to be the most visually appealing, original and representative of the 'Pups in the Park' theme. The winners will be notified within five working days of the close of the competition. Unsuccessful entrants will not be contacted. All decisions made by SMP will be final and no feedback will be given.

- 11. Copyright in all images submitted for the Pups in the Park Calendar Competition remains with the respective entrants. However, by providing the image(s), the entrants grant a licence to SMP to feature their submitted images in any publications, on their website, Facebook page and/or in any promotional material connected to the said calendar. Only the 12 winning images chosen for the calendar will be used.
- 12. Images must not:

12.1 Include faces or personally identifiable information about any other persons other than the submitter and their immediate families.

12.2 Include alcohol, cigarettes, firearms or offensive weapons.

12.3 Be shown to be promoting a company, brand, party, right or movement other than SMP.

12.4 Include copyrighted materials or trademarks owned by third parties.

12.5 Include any infringing, threatening, false, misleading, abusive, harassing, libellous, defamatory, vulgar, obscene, scandalous, inflammatory, pornographic or profane content.

12.6 Contain any material that could constitute or encourage conduct, which would be considered a criminal offence, give rise to civil liability, or otherwise violate any law.

12.7 Contain or infringe upon any copyrights, trademarks, contract rights, or any other intellectual property rights of any third person or entity. Each entrant agrees to fully indemnify SMP in respect of all royalties, fees and any other monies owing to any persons by reason of the entrant breaching any of the foregoing.

- 13. It is the responsibility of each entrant to ensure that the conditions within these terms are met, any images they submit have been taken with the permission of the subject(s) and do not infringe the copyright of any third party or laws, the photograph they are submitting is their own work and that they own the copyright.
- 14. SMP reserves the right, in its sole discretion, to disqualify and remove any entry that does not comply with any of the requirements listed in these Terms and Conditions. Notice of the decision does not need to be given.
- 15. SMP shall have the right, at its sole discretion and at any time, to amend these terms and conditions and such change shall be effective immediately upon sharing the information on our website.
- 16. SMP also reserves the right to cancel the competition if circumstances arise outside of its control.
- 17. All information detailing how to enter this competition forms part of these terms and conditions. It is a condition of entry that all rules are accepted as final and that the competitor agrees to abide by these rules. Submission of an entry will be taken

to mean acceptance of these terms and conditions. Failure to comply will result in the entry being withdrawn.
